There was a motion by Day and a second by Adam to make the appropriate revisions. All in favor – Motion carried 6-0.

Discussion and re-approval on revision to Chapter 5.08 – Tree Planting and Care: There was a motion to re-approve Chapter 5.08 – Tree Planting and Care by Hagen with a second by Day. All in favor – motion carried.

Discussion and approval on revision to Chapter 5.08 – Tree Board: There was a motion to approve revisions to Chapter 5.08 – Tree Board by Hagen with a second by Day. All in favor – motion carried.

Diesel Plant Upgrade Update – possible action: Gary Smith, Electric Superintendent, was present to discuss the Diesel Plant Upgrade. The Upgrade cost is estimated at \$704,000. There is \$300,000 available leaving \$400,000 to finance. There was much discussion and many questions asked. The Council asked Debi and Gary to work at getting the best solution and exhausting every effort to not have to raise electrical utility rates.

Approval of Trisha Wood to the Fennimore Library Board: There was a motion by Day and a second by Hagen to approve Trisha Wood to the Fennimore Library Board. All in favor – motion carried.

Update on interviews and negotiations for possible action on hiring of water/wastewater operator.: There was a motion by Adam and a second by Hagen to approve the hiring of Justin Tollefson as the new water/wastewater operator. All in favor – motion carried 6-0.
