Approval of revised Assigned Fund Balances for year ending 2020. During the 2020 Debi and the Auditors were discussing the Assigned Fund Balances and discovered some differences in amounts. The Auditors felt it necessary to go with the balances the City had and per our Fund Balance policy requires council approval. There was a motion by Roth and a second by Streif to approve the revisions keeping the dollar amounts consistent but having the ability to allocate to different titles. Motion carried 6-0 on a roll call vote.

Motion carried 6-0 on a roll call vote.

Approval of an ordinance to repeal and recreate Chapter 18 of the Municipal Code relating to Offenses: There was a motion by Hagen and a second by Streif to approve the ordinance to repeal and recreate Chapter 18 of the municipal Code relating to Offenses. Motion carried 6-0 on a roll call vote.
