## MINUTES OF THE REGULARCOUNCIL MEETING OF THE COMMON COUNCIL OF THE CITYOF FENNIMORE, GRANT COUNTY, WISCONSIN HELD ON MONDAY, OCTOBER 17<sup>TH</sup>, 2022

The Regular Council meeting of the Common Council was called to order by Mayor Ryan Boebel at 5:30 p.m.
